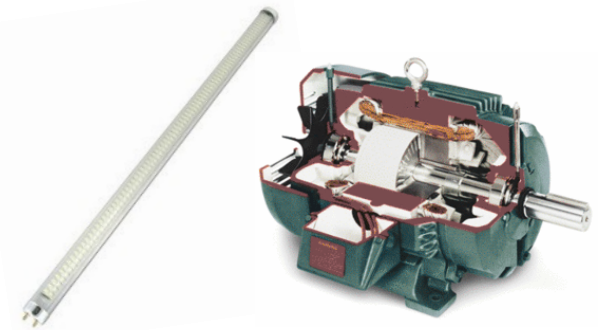

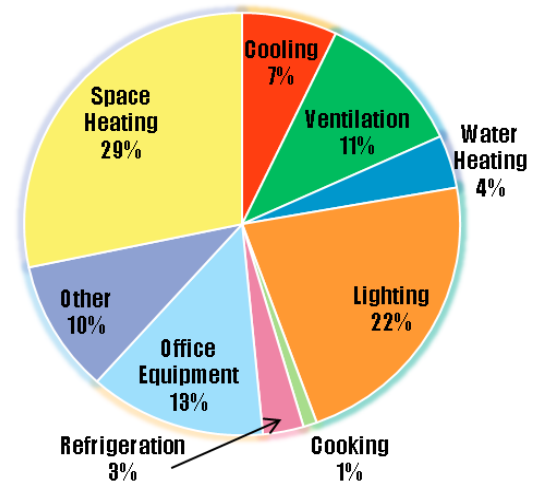

# Jamestown BPU Lighting & Motor Rebate Program

January 1, 2012 - December 31, 2012

The BPU is offering commercial and industrial customers financial incentives (rebates) for energy efficiency projects. The program's goal is to promote investment in new high quality lighting and motor equipment that operates at a very high level of electrical efficiency.

### Do I qualify?

Commercial and industrial customers classified as service class 2 or 3 qualify for the program.

### What is included in the rebates?

The purchase cost of new permanently installed light fixtures, ballasts, bulbs, sockets, LED exit signs, occupancy sensors, electric motor and variable speed drives qualify for the program. All T8 lamps and ballasts must be listed in the CEE directory, this directory is available online at [www.cee1.org](http://www.cee1.org).

### What is NOT included in the rebates?

Portable equipment and labor costs to install equipment are not included.

### Is there a limit to how much I can receive in rebates?

Yes, companies are limited to a maximum of \$15,000 of rebates annually.

### How do I participate?

Any project with a total anticipated rebate of \$1,000 or more must contact BPU Energy Efficiency Coordinator, Daniel Reynolds, at 661-1646 to have a lighting assessment conducted before the project begins. Forms and worksheets are also available at BPU Customer Service, 92 Steele Street; open 7 a.m. - 5:30 p.m. weekdays.

4' fluorescent 3 - or 4-lamp T8, Super T8, T8 HO	New fixtures or retrofit; lamps and ballasts must be new and must be listed in the CEE directory	Up to \$45 for new fixture; up to \$30 for retro fits
8' fluorescent T8, T8 HO	New fixtures or retrofit; lamps and ballasts must be new and must be listed in the CEE directory	Up to \$50 per fixture; up to \$35 for retro fits
LED Exit signs	New LED exit sign or new LED bulbs	Up to \$25 per fixture; up to \$10 for retro fits
Hard-wired compact fluorescent fixtures	Fixtures must be new	Up to \$25 per fixture
High Bay T5 fixtures	Fixtures must be new	Up to \$70 per fixture
Occupancy Sensors	Each unit shall be hard-wired, passive infrared and/or ultrasonic. Manual ON override capability are NOT eligible.	Up to \$30 per control

Ballast power consumption in low mode must not exceed 60% of full load. ON/OFF overrides and spaces under 250 sq. ft. not eligible	Up to \$60 per control
Metal Halide fixtures indoor/outdoor	Must have <b>pulse-start</b> fixtures and matching lamps	Up to \$60 per fixture
